We are committed to providing high-quality items and are pleased to offer you a comprehensive two-year warranty. Please review the terms and conditions outlined below:

Coverage:

This warranty covers defects in materials and workmanship for a period of two [2] years, under normal use and care. During this period, Electric Mirror will, at its discretion and without charge, repair or replace any product or part that fails due to such defects.

Commencement:

The warranty period begins from the date of delivery, whether directly to the property or to a warehouse.

Eligibility:

This warranty applies solely to the original purchaser of the product or their client and is nontransferable.

Scope of Warranty:

- Electric Mirror may make non-aesthetic alterations to product construction to suit the intended application and function for use in the customer's project.
- Electric Mirror's liability is limited to repair or replacement of defective parts or the purchase price of the product, at its sole discretion.
- Damages resulting from user modifications, misuse, abuse, negligence, accidents, improper maintenance, or transportation damage are not covered under this warranty and may void it.

Exclusions:

- Electric Mirror shall not be liable for lost profits, goodwill, stored data, or any general, special, consequential, or exemplary damages, even if notified of their possibility.
- Stone tops must be sealed immediately after installation and maintained per the sealant's suggested schedule for warranty coverage.
- Products used for purposes other than their intended use are not covered under this warranty.

Other Rights:

This Limited Product Warranty applies only to products manufactured by Electric Mirror. It provides specific legal rights, and additional rights may vary from state to state. Some states do not allow the exclusion of implied warranties or limitation of damages, thus certain exclusions and limitations may not apply.

Limitation of Liability:

This warranty constitutes the sole remedy for product defects, and no other express or implied warranty is provided, including but not limited to any implied warranties of merchantability or fitness for a particular purpose.

Buyer's Responsibility:

Buyers are responsible for receipt and verification of all items from the transport company. Products not installed upon receipt should be protected from elements until installation.
